- There were a few weeds in the area of the Lion Temple, and significantly more in the area of the German excavation??, in front of the Great Staircase
- The removed weeds were gathered in front J3
- A few pages of the signs are missing in the temple area
- There is no erosion on the walls of the temple
- Some debris has been observed accumulating in one corner of the Lion Temple
- The corner of the Panorama is broken
- The sign structures are in good condition
- No burning activity observed

**Suggestions:**

- The inspection of the Panorama is mentioned twice in the file, while the signs in the temple area are not mentioned at all. Please correct it.
- The pathways in the temple area require more attention and should be cleaned
- Remove the phrase “erosion” and place it together with “inspecting plaster on temple structure” in the file
- Remove the phrase " vegetation" and “debris” and place it together with " Checking for weed removal" in the file.
- Reordering the pages of the signs based on the observations from the website

- The burlap is deteriorated and needs to be replaced
- The sandbags are deteriorated and need to be replaced
- The signs are in good condition in both J1 and J5
- No burning activity observed
- The sandbags of the retaining wall in the J5 area are deteriorated

- Weeds were observed in front of the palace (the southwest side)
- The pathways in Palace areas require more attention and should be cleaned in
- The burlap in wall C2-3 is in good condition
- Wall C2-3 has many cracks and is in very poor condition, and the nylon was not fixed properly
- The wall H3-H1 has no cover
- There is no nylon on either wall C1-1 or H3-H1
- The sewage cover is not properly fixed
- The signs are in good condition
- The cover of the Tannur is broken
- There are some weeds on the floor of the courtyard in the area A16, and the northern section is crumbled
- Panorama in good condition
- Panorama casing is in good condition
- The signs are in good condition
- The protective system needs to be re-plastered
- No burning activity observed
- There are some gaps on the burlap
- The burlap on the wall B2-1 and the external face of the wall C2-3 need to be changed
